Sadly, I need to announce that a couple water professionals passed away this holiday season: Allan Moir and Greg McVeigh.



Allan Kenneth Moir, 63, of Kennebunkport, died Sunday evening, December 24, 2017 at Gosnell Memorial Hospice House. He was born in Worcester, MA on May 20, 1954, a son of George Allan Moir and Elise Marie (Toomey) Moir. Allan grew up in Upton, MA, and graduated from Blackstone Valley Regional Vocational Technical High School. Training to be a machinist, he worked for Bay State Abrasives in Westboro, MA. He then took a job as a plant operator with the Upton Sewer Department. While in Upton, he also learned the demanding and rewarding job of firefighter and EMT, working with the Upton Fire Department.

In 1977, he met his future wife, the former Donna Lee Carpenter, on a blind date. They were married on September 7, 1977, and celebrated their 40th anniversary earlier this year.

Allan and Donna moved to Maine in 1981 when Allan was hired by the Kennebunkport Wastewater Department. He became a well-respected member of the Washington Hose Company and, in 2010, was hired as Chief of the Kennebunkport Fire Department, a position in which he was serving at the time of his death. He was well loved by his firefighters, never asking them to do something he wouldn't do. Allan was also the proprietor of K-Port Divers. He taught SCUBA, tended moorings, and performed boat and ice rescues. When not working, he enjoyed being on his boat, hunting, fishing, and yardwork, ensuring Donna's garden was ready to plant. He was an Eagle Scout, and also held his private pilot's license.

In addition to his parents, Allan was predeceased by a brother, John Moir. He is survived by his loving wife of 40 years, Donna Lee Moir of Kennebunkport; a brother, Andy Moir of Surry, ME; two sisters, Elise Elbrecht of Lake Peekskill, NY, and Denise Smith of Upton, MA; nieces and nephews Andrew and Thomas Elbrecht, Amanda and Amber Moir, Cameron and Madeline Smith.

A Memorial Service will be held on Saturday, January 6, 2018 at 2:00 p.m. at Kennebunkport Village Fire Department, 32 North Street, Kennebunkport.

Gregory John McVeigh, age 65, died Saturday December 23, 2017 at Maine Medical Center, Portland.

## *Current Legislative Items*

**LD 178** An Act to Authorize a General Fund Bond Issue To Provide Jobs, Improve Road Infrastructure and Protect Water, sponsor Rep. Black. Bond proposal focused on culverts. May be rolled into DEP wastewater bond.

*Status:* Public hearing on 1/9/18, no work session date set.

**LD 399** An Act to Revise's Maine's Environmental Laws, sponsored by Rep. Tucker. This is a one sentence concept draft that is a placeholder for any changes Rep. Tucker, the House Chair of the Environment and Natural Resources (ENR) Committee, may wish to make. At the work session on 2/8, Len Blanchette and others presented an amendment regarding municipal satellite collection systems based on the stakeholder group created in response to LD 881. ENR will accept comments on the amendment on 2/14 @ 1:00. There was some opposition to the amendment, but it was ultimately included in the amended version approved unanimously by the Committee.

*Status:* ENR voted unanimously OTP-A on 2/14/18.

**LD 467** An Act To Authorize a General Fund Bond Issue To Address Changes in Sea Level, sponsored by Rep. Devin. Provides \$5 million for detailed mapping and sea level monitoring to improve sea level prediction models.

*Status:* Public hearing on 1/10/18, no work session date set.

**LD 964** An Act To Authorize a General Fund Bond Issue To Upgrade Municipal Culverts at Stream Crossings, sponsored by Rep. Fredette. Provides \$10 million for a competitive grant program to assist municipalities with culvert upgrades. Municipalities must provide match.

*Status:* Public hearing on 7/17, no work session date set.

**LD 1298** An Act to Update Maine's Water Quality Standards. Updates Maine's water quality standards regarding certain pesticide application and authorized DEP to use alternative low-flow requirements when assessing the impact of nutrients on water quality, contingent on adopting new nutrient rules.  
*Status:* Passed to be Enacted, Signed by the Governor, 2017 Public Law 319.

**LD 1472** An Act To Lower the Costs of Broadband Service by Coordinating the Installation of Broadband Infrastructure, sponsored by Rep. McLean. The bill requires public entities constructing certain projects, including water or sewer lines in the right-of-way of a public road, to install broadband conduit as part of the project. The conduit may be leased to communications companies. Tim Haskell testified in opposition for MEWEA. The EUT Committee significantly changed the bill to simply support information sharing among utilities.

*Status:* EUT Committee voted unanimous OTP-A on 2/8/18. The amendment will only require notification to broadband companies of when a road opening permit is requested.

**LD 1510** An Act To Authorize a General Fund Bond Issue To Fund Wastewater Infrastructure Projects for Ratification by Voters in the June 2017 Election, sponsored by Rep. Fredette. This is the DEP wastewater bond bill for \$50M. MEWEA strongly supports.

*Status:* Public hearing on 1/9/18, no work session date set.

**LD 1831** An Act Concerning Remote Participation in Public Proceedings, sponsored by Rep. Moonen. This bill was issued by the Judiciary Committee pursuant to statute. Along with LD 1832, it offers two different models to address the remote participation question. This bill would prohibit remote participation in meetings of any body subject to the Freedom of Access Act, except for the 7 that already have statutory provisions allowing it.

*Status:* Referred to Judiciary. Public hearing on 2/22/18 @ 1:00.

**LD 1832** An Act Implement Recommendations of the Right to Know Advisory Committee Concerning Remote Participation, sponsored by Rep. Moonen. This bill was issued by the Judiciary Committee pursuant to statute. Along with LD 1831, it offers two different models to address the remote participation question. This bill would only allow remote participation pursuant to a written policy and requires that the public be able to hear remote participants and that a physical quorum must be present.

*Status:* Referred to Judiciary. Public hearing on 2/22/18 @ 1:00.




# President's Message







CHAPTER NUMBER AND TITLE: Ch. 263; Maine Comprehensive and Limited Environmental Laboratory Accreditation Rule;

BRIEF SUMMARY: The proposed Maine Comprehensive and Limited Environmental Laboratory Accreditation Rule repeals and replaces Maine Comprehensive and Limited Environmental Laboratory Certification Rules. This proposed rule contains quality guidelines for laboratory data received by the DHHS and the DEP to help ensure that laboratories analyzing samples for the following regulations: Safe Drinking Water Act; Clean Water Act; Resource Conservation and Recovery Act; and Leaking Underground Storage Tanks (LUST) Program, for compliance purposes, produce legally defensible data by meeting quality control and quality assurance objectives. This rule proposes an all-encompassing quality systems section for easy reference and includes the following: 1) references to the most recently updated 40 CFR, as applicable to the methods test categories specified; 2) "provisional status" as an additional accreditation option; and 3) reporting requirements for Maine laboratories when samples are not analyzed according to accredited methods, including those for private well samples. Proposed changes amend definitions and replace the term "certification" with "accreditation" to keep consistent nomenclature with national and international standards. Additionally, the proposed rule corrects grammatical inconsistencies, formally establishes an adjusted fee structure, and presents a new construction and format for improved clarity and conformity to standard conventions.

Dear MEWEA members,

It saddens me to inform you all that Jerome “Frenchie” Guevremont recently passed away. He was a beloved member of the water environment community in Maine and he will be deeply missed.

Frenchie became a licensed wastewater treatment plant operator in 1975. He settled in Rangeley and became the first supervisor of Rangeley's new wastewater treatment facility, where he was the superintendent until he retired in 2014. He was instrumental in promoting the legislation that created JETCC back in the early 1980's. Throughout his career, Frenchie continued to demonstrate support of operator training in the state of Maine and was consistently active in MEWEA (then Maine Wastewater Control Association).



In 2006, JETCC first awarded the Founders Award, which is named in honor of Frenchie. The award recognizes him for his guidance to Maine's environmental community, for his years of service to the Town of Rangeley Maine, and for his contributions as one of the original founders who established JETCC. An excerpt in the award description states “As a wastewater professional, and a protector of Maine's waters, Frenchie tirelessly shared his expertise to promote our profession, to educate the general public, to cultivate new wastewater operators and to advance the education and training opportunities for water pollution control professionals in the State of Maine.”

Frenchie's family is planning a celebration of life to be held this fall for both him and his predeceased wife, Eleanor. I will relay details as soon as I have them.



I hope you all had a fun and safe holiday weekend. Things have been relatively quiet recently, but I did want to reach out and make you aware of a couple things.

Last month MEWEA provided written comment for the proposed changes to Chapter 263, Maine Comprehensive and Limited Environmental Laboratory Accreditation Rule. In short, we asked that *Enterococcus* be added to the list of tests POTW's are allowed to test for in-house without being certified (i.e. accredited). I've heard that DEP is working on getting a new exemption into law for this, but it will likely not be approved until September 2019. They will not begin to put *Enterococcus* testing into permits until this approval goes through.

## MaineDOT Proposed Rulemaking

I also want to make you are aware of the proposed changes to Chapter 210 "Utility Accommodation Rules". Follow [this link](#) to access and review the proposed changes. # 2018 Maine Water Quality Bond

*Question 2: Bond Issue (Public Law 425)*  
 Do you favor a \$30,000,000 bond issue to improve water quality, support the planning and construction of wastewater treatment facilities and assist homeowners whose homes are served by substandard or malfunctioning wastewater treatment systems?



- If approved, this \$30,000,000 bond will fund three wastewater infrastructure /water quality grant programs at DEP that provide grants to upgrade municipal/ quasi-municipal wastewater infrastructure (treatment plants, pump stations, sewer systems), remove overboard discharges and repair/replace malfunctioning septic systems that impact surface water.
- There are approximately **\$1 billion of known needs** to upgrade Maine's wastewater infrastructure.
- All three programs create jobs, improve water quality, and protect and/or open shellfish areas.
- These bond funds will be combined with other federal and state funds to facilitate important wastewater infrastructure projects. An estimate of the leveraging potential is 150% or more, resulting in approximately \$71,475,000 of wastewater infrastructure projects.
- Although bonds for these programs were approved from 1992 through 2010, there have been none since 2010.

Program	Bond Amount	Purpose / Benefits
Municipal Wastewater Infrastructure Grants	\$27,650,000	Municipal and quasi-municipal wastewater infrastructure projects including combined sewer overflow (CSO) abatement.
Small Community Grant Program	\$2,000,000	Repair or replacement of failed septic systems impacting surface water.
Overboard Discharge Removal Grant Program	\$350,000	Removal of commercial and residential overboard discharges (OBDs) with goal to open shellfish areas.
<b>TOTAL</b>	<b>\$30,000,000</b>	



## Jobs

It is estimated that 540 jobs (such as construction and engineering related jobs) will be created or sustained from the bond funds and 1,287 total jobs will be created or sustained from the combined bond and leveraged state and federal funds.<sup>1</sup>

Shellfish harvesting jobs: In addition to the jobs noted above, abating combined sewer overflows, removing overboard discharges, and repairing/replacing malfunctioning septic systems all have the potential to open closed shellfish areas so they can be harvested.

## Water Quality

Maintenance and upgrading of this “invisible”, yet essential, infrastructure is **critical to protect public health, to protect water quality, and support economic growth.**

The Maine Section of the American Society of Civil Engineers (ASCE) **rated Maine with a grade of D+** for Municipal Wastewater Infrastructure. The lack of funding for infrastructure investment and proper maintenance adversely affects Maine’s ability to protect water quality and public health.<sup>2</sup>

## Potential Projects

There are approximately \$1 billion of known needs to upgrade Maine’s municipal wastewater infrastructure. Wastewater infrastructure (wastewater treatment facilities, pump stations, and sewer systems) is typically the highest value asset a community owns and in some circumstances, cannot be affordably sustained solely through local rate payers. Based on current known needs there are numerous projects that are good potential candidates for grant funding.

DEP will solicit detailed project requests to determine how the grants will be awarded. Project requests will be evaluated using longstanding DEP criteria including economic need, shellfish area protection and improvement, abatement of combined sewer overflows, water quality improvement, regionalization, and leveraging bond funds with other state and federal funding sources.
